교과목개요

이 과목은 우리들의 삶에 커다란 영향을 미치고 있는 국제관계를 본격적으로 이해하려는 노력이 역사적으로 그리고 공간적으로 어떻게 전개되어 오늘에 이르고 있는가를 추적한다. 따라서 근대 국제정치학의 유럽적 탄생, 미국으로의 중심이동, 동아시아를 비롯한 전세계적 전파와 변용 문제를 다루게 될 것이다. 이러한 시도는 현대 국제정치학의 국제정치적 성격을 제대로 이해하기 위한 노력이며, 더 나아가서 우리에게 필요한 한국, 아시아, 그리고 세계정치학 모색의 첫걸음이다.
